ARTIST ELIGIBILITY

The IWA WILDLIFE ART EXHIBIT is open to artists who reside in the United States and whose work shows a serious approach to wildlife art.

EXHIBIT FEE

- The exhibit fee for current members is included in the membership dues.
- Non-member's entry fee is \$50 for up to three entries, and membership for the remainder of the year. Non-member's work will be juried before their application is accepted.
If non-member's application is not approved by the jury, the entry fee will be returned.

METHOD OF ENTRY

Artists may submit up to three entries, either by USPS or by email. (An application is attached at the end of this prospectus).

- Non-members must submit an image of each piece for juried approval.
- FOR MEMBERS AND NON-MEMBERS BOTH:
 - If you wish your artwork to be displayed in the on-line catalog on the website, please send good quality images taken before framing. (Photograph straight on in a bright location but not in direct sunlight or using a flash.) See more details under **EXHIBIT PROMOTIONS**.
 - If mailing application by USPS, you may include 4" x 6" prints (not glossy) or .jpg images on disc or thumb drive.
 - If sending application by email, include .jpg files individually or in a zip file.
(.jpg files preferably should be 5MB or less)

✓ **Submitted photos, CDs or thumb drives will not be returned unless a self-addressed, stamped envelope is included.**

✓ **Please identify each image with artist's name, title, subject and medium.**

2021 INDIANA WILDLIFE ARTISTS EXHIBIT

DEADLINE FOR ENTRIES AND FEE:

IWA Exhibit Entry forms and samples of work are to be received after **MAY 1st** but no later than **FRIDAY, July 2, 2021**. This deadline date must stand because of the Virtual Exhibit, the Catalog, and the Judges' Virtual Gallery even if a live exhibit is possible this year.

MEDIA:

Two and three-dimensional work may be entered in any of the listed categories. Mixed media should identify the most prominent medium used.

****CATEGORIES:** (**reference for application attached)

- 1. PAINTING:** Oil, alkyd; acrylic; transparent or opaque watercolor or any liquid media.
- 2. DRAWING:** Pastel; charcoal; graphite; colored pencil; scratchboard; ink.
- 3. PHOTOGRAPHY:** Film or digital with or without standard enhancements; film or digitally altered, digitally manipulated images.
- 4. DIGITAL ART:** Using digital technology that imitates any or all of the above categories. May include photo, painting and drawing manipulation.
- 5. THREE-DIMENSIONAL:** Carving and sculptures created in any durable material.
- 6. MIXED MEDIA & OTHER:** Any combination of media or artwork not covered in above categories.

✓ **ALL LANDSCAPES MUST HAVE A SPECIFIC IDENTIFIABLE WILDLIFE SUBJECT (Flora or Fauna)**

ELIGIBLE ARTWORK:

- The artwork must show a serious approach to nature and depict one or more species in a manner which captures the essence of the subject.
- All subjects – zoological and/or botanical, must be WILD – no domestic animals or plants will be accepted – nor man-made objects, unless found in the subject's natural habitat.
- Entries submitted may not have appeared in previous IWA exhibits.
- THERE WILL BE NO SUBSTITUTIONS FOR ACCEPTED ENTRIES.**
IWA RESERVES THE RIGHT TO REFUSE WORK WHICH DIFFERS MARKEDLY FROM THE DESCRIPTIONS AND/OR IMAGES SUBMITTED WITH THE ENTRY FORM, OR THAT IS IN VIOLATION OF THE RULES STATED HERE.
- ALL WORK MUST BE ORIGINAL. THE CONCEPT MUST BE THE ARTIST'S OWN. PHOTOGRAPHS USED IN CREATING THE WORK MUST HAVE BEEN TAKEN BY THE ARTIST OR USED WITH WRITTEN CONSENT OF THE PHOTOGRAPHER.**

SPECIFICATIONS:

TWO-DIMENSIONAL entries must be framed with wire and flat-strap hangers in place. Saw-tooth hangers and screw- eyes are not permitted.

SIZE LIMITS: no larger than 40" x 40".

TOTAL MAXIMUM SPACE allocated for each artist: 2,500 square inches.

EXAMPLE 1: 40" x 40" = 1,600 sq. in.

EXAMPLE 2: 18" x 24" canvas plus 2" frame (total 20" x 26") = 520 sq. in.

EXAMPLE 1 AND 2 TOGETHER = 2,120 sq. in.

THREE-DIMENSIONAL entries must be freestanding (no installation of pieces will be accepted). Restrictions may apply to entries which exceed 28" high by 18" deep or weighing over 25 pounds.

VIDEOGRAPHY, ANIMATION AND 3D VIRTUAL SCULPTURES must be appropriately framed by the artist and if to be hung, must be able to be hung as regular two-dimensional artwork.

2021 INDIANA WILDLIFE ARTISTS EXHIBIT

DELIVERY OF ARTWORK:

For accepted exhibitors, directions to the venue will be included in the exhibit packet which will be mailed to you. The packet will include identification labels for each piece accepted. These labels must be attached to the back of the corresponding two-dimensional piece **in the upper left corner**, or the **bottom of a three-dimensional piece**.

ALL ENTRIES ARE TO BE HAND DELIVERED ON:

FRIDAY, AUGUST 27, 2021, between 2:00 and 4:30 p.m.

OR

SATURDAY, AUGUST 28, 2021, between 8:00 and 9:30 a.m.

OUT OF STATE ENTRIES must also be delivered and retrieved by hand.

IWA will not accept and/or ship artwork.

Please arrange for delivery and pick-up of your work.

JUDGING:

The judging panel consists of a fine artist and a naturalist, who are recognized for their expertise. All work will be judged for quality of artistic presentation and appropriate depiction of both wildlife and habitat. Both judges will agree on recipients of major awards. At the judges' discretion, ribbons and cash awards will be awarded for First, Second and Third Place in each category. The judges may also award up to two Honorable Mention ribbons in each category. Presentation of awards will take place at the Award Ceremony on **SATURDAY, AUGUST 28, 2021**. (See Calendar following for more details.)

SALES:

Exhibited artwork need not be for sale, however sales during the exhibit are encouraged, if you so wish. A 40% commission will be taken out of all sales during the exhibit, which goes to the Minnetrista Cultural Center.

EXHIBIT PROMOTION:

IWA reserves the right to reproduce any artwork for publicity in print or on the website, unless the artist stipulates otherwise in writing at the time of entry.

A VIRTUAL CATALOG and EXHIBIT will be available ON-LINE by AUGUST 28, 2021

The catalog will feature a brief biographical statement about each artist. The Virtual Exhibit will display your work in the chosen category with title, subject, medium, dimensions, and Artist. If this is the first time you are entering, or if you wish to change your current bio, please include your statement on a separate paper. Keep it relevant to your artwork. **Please include photos of each of your entries** – preferably in digital format for quality representation of your work. If sending a photograph, please use non-glossy paper for best results for scanning purposes.

LIABILITY:

Reasonable precautions will be taken to safeguard all entries.

The Oakhurst Home at the Minnetrista Cultural Center, IWA and the Board Members of both organizations, as well as the volunteers handling the artwork assume no responsibility for the safety and security of artist's works, or participation in the IWA exhibit.

Artists entering the IWA exhibit acknowledge and accept their personal responsibility to provide, if desired, their own insurance coverage relevant and appropriate for such an event.
